**Publications:**

I have authored or co-authored numerous professional publications, mostly peer-reviewed. In 1997 I authored and programmed an interactive CD ROM on Rheumatology which was published by Cambridge University Press. I have also refereed numerous papers for a variety of medical journals.

**Clinical Work:**

I have provided a monthly visiting rheumatology service to Guernsey since 1997. Clinical Lead for Rheumatology in Southampton from 1998-2014.

**Other work experience:**

Visiting Professor of Rheumatology, Al Mouwasat Hospital, Dammam, Saudi Arabia – 28<sup>th</sup> January 2000 to 10<sup>th</sup> February 2000. (Conducting clinics and lecturing). I have also worked privately but ceased private practice on 31 March 2024. I prepare medicolegal reports on a regular basis on various matters including personal injury and medical negligence. I have acted as a referee for several rheumatology learned journals.

**Medicolegal work:**

I am asked to prepare reports by solicitors working on behalf of the claimant and the defendant in a ratio of approximately 55:45. There are also a number of Joint Instructions. I currently prepare in excess of 40 medicolegal reports each year. I undertake clinical negligence work and also regularly prepare reports for the MDU, MPS and MDDUS and the GMC. I am a member of the UK Register of Expert Witnesses and a member of The Faculty of Expert Witnesses for Doctors. I have given evidence in Court on many occasions and have been preparing reports for more than 25 years. In November 2012 I attended a SpecialistInfo Medical Negligence Course in the Strand, London and since November 2016 onwards, the Annual Bond Solon Expert Witness Conference in London as well as other CPD activities relevant to medicolegal work.

I confirm that I act in accordance with the guidance “Acting as an expert or professional witness – Guidance for healthcare professionals”, which is endorsed by the Royal College of Physicians of London and is consistent to the standards and guidance of the General Medical Council.

**Teaching:**

I have been involved in delivering undergraduate teaching in rheumatology for medical students at Southampton University Medical School and have also frequently actively participated in postgraduate medical education for General Practitioners, junior hospital doctors in training and other professional groups allied to medicine.

**Medical Informatics:**

I have an active interest in the application of IT to healthcare and in addition to my work for the National Library for Health (now NHS Evidence) I was involved in developing an electronic patient record application for my specialty in Southampton. For this I received an NHS Leadership in Health Informatics Accolade Scheme award in 2004.
