QUALIFICATIONS & EXPERIENCE

My qualifications are MBChB MRCS PGCE(Dist) FHEA FRCS(Tr&Orth). I hold a substantive Consultant appointment at the East Suffolk North Essex NHS Foundation Trust, treating both adult & paediatric traumatic injuries, and in elective practice, children & young adults with a wide range of orthopaedic conditions.

I am a **Cardiff University Bond Solon Certified *Expert Witness*** (Civil) and a registered Medco Indirect Medical Expert.

I have over fifteen years of experience in general Trauma & Orthopaedic Surgery, treating both adults & children. I was entered onto the GMC Specialist Register for *Trauma & Orthopaedics* in 2015.

I undertake a one in twelve General Orthopaedic oncall within a Trauma Unit, treating both adults & children. I undertake a weekly general orthopaedic fracture clinic.

Since Consultant appointment in 2015, my elective practice has become increasingly sub-specialized primarily in Paediatric Orthopaedics, transitional age adult foot & ankle surgery & adult disability.

Previous Experience

I was appointed to the position of *Trauma & Orthopaedic Registrar* on the Southwest Peninsula rotation in 2007 following successful completion of basic surgical training. My general orthopaedic training was undertaken at The Royal Cornwall Hospital, Derriford part-MOD Major Trauma Centre Plymouth and the internationally renowned Princess Elizabeth Orthopaedic Centre Exeter.

In 2012 I successfully passed the Royal College of Surgeons of Edinburgh Intercollegiate Fellowship examination in Trauma & Orthopaedics (FRCS Tr&Orth) at the age of 31.

As a senior trainee, I developed a specialist interest in adult Foot & Ankle surgery, Paediatric

Orthopaedics & Trauma.

I subsequently undertook further sub-specialist fellowship training in Paediatric Orthopaedics at two internationally recognized centers of excellence; Starship Children's Hospital Auckland New Zealand and The Children's Hospital at Westmead, Sydney Australia; in addition to further specialist training in adult Foot & Ankle surgery at the Royal Cornwall Hospital.

In recognition, I was awarded the Zimmer Travelling Trauma Fellowship Grant in 2013 by the British Orthopaedic Association and 2013 Ethicon Travelling Fellowship Grant by the Royal College of Surgeons of Edinburgh.

Academically I have published research extensively on all aspects of adult & paediatric Trauma & Orthopaedics, and presented at scientific meetings both nationally & internationally. In 2013 I was co-recipient of the Orthopaedic Research UK prize, and have previously been awarded the Ling-Lee prize, Southwest Orthopaedic Club prize, British Orthopaedic Specialists Association prize for best Podium presentation & best Poster presentation, in recognition of original research. I have a strong commitment to teaching and medical education, obtaining a Postgraduate Certificate in Clinical Education from the Peninsula Medical School in 2013, passed with Distinction.

Between 2015 – 2023, I was a Paediatric Orthopaedic Consultant at The Norfolk & Norwich NHS Trust. The Norwich Paediatric Orthopaedic Unit is a tertiary referral center, serving a further four peripheral hospitals across East Anglia, covering all aspects of Paediatric Orthopaedics, musculoskeletal infection & paediatric trauma, with dedicated virtual and face-to-face paediatric trauma clinics.

Consultant Practice

My Consultant practice comprises the following:

1. General Trauma Oncall – adult & paediatric trauma operating & fracture clinics, including bony & soft tissue injuries. (I do not operate on spinal injuries).
2. Paediatric Orthopaedics - treatment of children, adolescents & teenagers with wide

range of traumatic and non-traumatic disorders of the lower limb, upper limb and selected spinal disorders including neck & back pain.

3. Disability - treatment of disabled children and adults with neuromuscular disorders & complex disabilities, including cerebral palsy.
4. Foot & Ankle Surgery - paediatric & adult (teenage and transitional age) patients with foot & ankle disorders.

Medico-legal Practice

I commenced medico-legal practise in 2015. I undertake reporting in both adults and children, with witness activity split approximately: 80% claimant, 10% defendant, 10% single joint expert. I produce approximately 150-175 reports per year.

I am MedCo registered as an Independent Medical Expert (IME8727), having completed MedCo Mandatory Accredited Training in October 2022.

I am a **Cardiff University Bond Solon Certified Expert Witness** (Civil Law), completed in October 2022.

My medico-legal practise comprises the following areas;

- General medico-legal reporting for soft tissue personal injury claims as defined in 1.1(16A) of the Pre-Action Protocol (MedCo accredited & registered), in adults & children.
- Expert & specialist medico-legal reporting in Paediatric Orthopaedic cases, for complex bony injuries, personal injury.
- Clinical negligence reporting in Paediatric Orthopaedics.

I have acted as Expert Witness in a variety of high value Paediatric Orthopaedic cases.

I am experienced in case conferences, joint statements and have attended Court twice.
