1. Delay in the diagnosis of breast cancer on mammograms in which early stage disease (ductal carcinoma in situ) had been missed
2. Contrast extravasation (injection of CT contrast or dye into the subcutaneous tissues rather than the veins) resulting in upper limb injury
3. Failure to diagnose deep venous thrombosis (clot in the veins) on ultrasound of the legs which subsequently presented with pulmonary embolus (clot in the lungs)
4. Delayed diagnosis of loosening of a hip replacement on x rays
5. Delayed diagnosis of Hodgkin Disease (lymphoma) on a CT scan
6. Delayed diagnosis of Colorectal (bowel) cancer on a CT scan
