## PROFESSIONAL EXPERIENCE AND INTERESTS:

I was a self-employed Consultant Ophthalmic Surgeon specialising in Cataract and Refractive Surgery and contracting to various clinics throughout the United Kingdom. I retired from active clinical practice in 2020 and now concentrate on my busy medicolegal practice, working through my own company, Medicolegaleye Ltd.

I worked as part-time Clinical Director/Lead Physician of the Optilase Laser and Refractive Clinic, Republic of Ireland and Northern Ireland from August 2011 to July 2018. I have performed in excess of 50,000 laser vision correction procedures (LASIK/LASEK/PRK); having been active in the laser eye surgery field for the past 23 years, proficient in the use of all the major excimer laser platforms.

Prior to his retirement I worked in close association with Prof. Emanuel Rosen, an acknowledged leading Ophthalmic medico-legal expert, at consulting rooms we share at St John Street in Manchester. We still occasionally discuss complex medico-legal cases.

Before moving to the United Kingdom in December 2001, I was in private Ophthalmic practice in South Africa. This was essentially general in nature, involving all the Ophthalmic disciplines including Paediatric, Anterior Segment, Glaucoma, Retinal (Medical and Surgical), Neuro-Ophthalmic and Oculoplastic. I am competent to diagnose and treat conditions from all these disciplines. My medicolegal work involves injury-related clinical negligence, criminal work and Family Court matters dating back to 2002.

In the UK, as of February 2020, I undertook NHS contract work as a part-time Consultant Ophthalmologist, working in the fields of General Ophthalmology, Medical Retina and Glaucoma. I ceased NHS work in 2020.

I am competent to diagnose and treat conditions from all the above disciplines. My medico-legal practice is more-or-less evenly split between injury-related and clinical negligence work. I currently produce approximately 300 reports per annum.

In respect of my Expert Witness experience in Paediatric Ophthalmology Care Proceeding cases, I have completed in excess of 100 Paediatric Ophthalmology instructions within the past 10 years including strabismus, ocular injury and many Shaken Baby Syndrome (Non-Accidental Injury) cases as well as having attended court on 20 occasions within the past two years.

Personal injury reports attract a fee of £295 plus VAT per hour plus costs of any specialist tests, and investigations. Negligence reports attract a fee of £325 plus VAT per hour. We can supply estimates for individual cases on request.

# FAQs for instructing solicitors and medical report agencies

*Where do you hold clinics for ophthalmic medico-legal examinations?* We hold clinics at our Manchester (10 St John St, M3 4DY) and London (46 Wimpole St, London, W1G 8SD) practices.

*What is your postal address?* Please contact us before posting anything. We prefer electronic means of communication only.

How often do you hold each clinic? Clinics are held each month.

What is the average turnaround time between a letter of instruction and the date of examination? Usually one month or sooner – provided that we have agreed to accept the instruction in advance. We do not recommend sending instructions without prior discussion; <u>we only accept records, documents and correspondence</u> via email or secure download link.

What is the average time between the examination and the provision of the medical report? Reports are currently being produced within one to two weeks.

How much is the whole report?

Personal Injury reports usually attract a fee of £885-1180 plus VAT. Clinical Negligence reports usually attract a fee of £1180-1770 plus VAT. Please see next page for more information.

Is VAT payable on your medical report?

Yes, VAT is payable on our medical reports.

*Can payment be deferred until successful recovery of costs at the end of the claim?* No. Payment is due within 30 days of receipt of the report. We do not participate in deferred payment schemes.
