I have been in medicolegal practice from 2002, with an increasing focus on providing reports on complex fractures (upper and lower limbs), seriously injured patients, and those with multiple fractures. My reports are illustrated, and with accompanying photographs if necessary, and are fully referenced to the orthopaedic literature where appropriate.

I hold a post-graduate diploma with commendation in Medical Law. I maintain annual medicolegal CPD using accredited learning and reflection from reading judgments.

## Clinical Experience

---

I have been a full-time Consultant in Orthopaedic Trauma and Limb Reconstruction from 2002.

I treat the generality of orthopaedic trauma, and “major trauma” including multiply injured patients regularly. My specific area of acute trauma expertise is in treating complex fractures of both upper and lower limbs, multiply injured patients, open fractures, and the use of external fixation devices for severe fractures.

My entire elective practice is in the treatment of complications of fractures in both the upper and lower limbs – these include nonunion, malunion, infection, joint stiffness and contractures.

I also carry out limb lengthening and treat limb deformities, and regularly treat bone infection (osteomyelitis) in both upper and lower limbs.

I am an Examiner Assessor for the Intercollegiate Surgical Board and the International Surgical Board. I was previously Training Programme Director, member of the Specialist Advisory Council, and part of Council of the British Limb Reconstruction Society.
