Introduction

Francis Morris is a part-time Consultant in Emergency Medicine (A & E) living and working Sheffield. He qualified in 1982 and has over 30 years experience in Accident and Emergency Medicine.

Francis Morris was Clinical Director in Sheffield from 1997 to 2016 and oversaw the Emergency Department, Minor Injuries Unit, the Major Trauma Centre and the department of Acute Medicine.

Since April 2017, his role as a Consultant has been to focus exclusively on clinical governance and risk. He is responsible for investigating all clinical incidents, claims and some complaints and reducing risk in the Emergency Department and Major Trauma Centre at Sheffield Teaching Hospitals.

This non-clinical role involves interviewing staff and patients to identify the root cause of errors allowing the completion of Serious Untoward Incident (SUI) reports for families and the Coroner.

This role requires that he is current in all aspects of patient care and safety, changes in investigation and treatment, approaches to clinical management; national, College and local guidelines and Duty of Candour requirements.

His clinical and examination skills are maintained through the clinical assessment of patients for personal injury claims and regular CPD to meet the requirements of annual appraisals.

Mr Morris has been preparing clinical negligence reports for the past 27 years and estimates that he has produced over 2500 reports to date.

He finds clinical negligence work informative, educational and that the lessons learned help to improve patient safety.

He has the expertise to comment upon all aspects of management in the Accident and Emergency Department.

He is the author of seven books on Emergency Medicine and regularly talks at medico-legal conferences.

MEDICO-LEGAL EXPERIENCE

Clinical Negligence

Mr Morris has been preparing medical negligence reports on all aspects of accident and emergency work for the last 27 years and in total he estimates that he has prepared over 2500 reports.

He has participated in multiple Case Conferences and has prepared many joint statements with other experts and given evidence in the County, High and Coroners court as recently as November 2018.

He is registered with Action for Victims of Medical Accident (AvMA) and APIL.

He has participated in several training courses on report writing and giving evidence in Court, the last being in November 2008. He has to date been instructed by claimant representatives (60%) and by the defendants representation (40%).

Francis Morris has been preparing reports on behalf of personal injury claimants for the past 27 years. He estimates that during this period of time he has prepared over 5,000 reports on whiplash claimants and 5,000 reports on work related accidents. 


