CONTRIBUTIONS TO MEDICAL PRACTICE

- I was one of the earliest operators in fiberoptic bronchoscopy in the UK. I directed the service at The Royal Brompton Hospital 1980 – 2003 and was instrumental in the establishment of bronchoscopy services at the following hospitals: Hammersmith Hospital, Whittington Hospital, Benenden Hospital, Kent & Sussex Hospital, St. Mary's Hospital, Charing Cross Hospital, Westminster Hospital, King's College Hospital, Dewsbury District Hospital, Addenbrooke's Hospital, Cambridge, St. Bartholomew's Hospital, the (Royal) London Hospital and Wexham Park, Windsor and Chertsey Hospitals. I have published a number of papers and a book in this field and I have trained more than 50 operators.
- Research output of my Group established the statistical and practical dose levels for treatment of severe asthma with systemic steroids.
- Having investigated the first person in the UK with AIDS, our team later defined methods for the safe investigation of patients with HIV infection, particularly with lung and heart complication. We also introduced sputum induction as the safest method for the diagnosis of pneumocystis pneumonia, a leading cause of death in AIDS.
- I became the lead investigator for rejection crises of patients with lung and heart-lung transplants performed by Professor Sir Magdi Yacoub and John Pepper. We defined the cellular and microbiological features of the rejection process in lung. Dr David Mitchell and I showed that bronchoscopic biopsy is the best method for confirming the diagnosis of sarcoidosis. With Professor Dame Margaret Turner Warwick we pioneered the use of broncho-alveolar lavage to distinguish the different types of interstitial (structural) lung diseases.
- The work of my Research Fellows Dr P Hanson and Dr T R Leigh established internationally accepted standards for disinfection routines and clinical methods in the management of cross infection with HIV, Hepatitis and mycobacterial agents.
