Terms and Fees:

My fees are based on an hourly rate of £200. The fee for a typical personal injury examination and report would be £400-500. The fee for an average sized typical clinical negligence report would be approximately £1000-1200. You will receive my report within 4 weeks of receipt of the case file. My payment is not reliant on the outcome of the case and invoices are payable within 4 weeks. If I am asked to appear as an expert witness, my fee will be £500 per half day, plus any expenses. If, having required my attendance at a hearing, such attendance is cancelled on less than 4 weeks' notice, 50% of my fees for the whole of the allotted time will be payable. If I receive less than 14 days notice 75% is payable and if less than 7 days notice, the whole of my fee for the allotted time will be payable. My fee for attending a case conference will be £200 per hour from the time that I leave my hospital base, until the time that I return.
