For this purpose, TLC has raised more than £2M in cash and kind donations. MEDICO-LEGAL

I have been providing expert medico-legal reports consistently for more than 20 years.

These have mostly involved clinical negligence but also personal injury, where appropriate and within my area of expertise.

My principal areas of medico-legal expertise are general surgery, renal transplantation, the surgery of renal failure and endocrine surgery.

Over the past few years, I provided between approximately fifteen reports per year, as permitted by time availability after attending to my my clinical practice, research program and international activity. These reports have invariably involved highly complex cases in which multiple reports have often been required. Equally, I have experience in writing short-form/ overview reports.

Instructions have been equally divided between defence and claimant, with my principal consideration being the provision of a truthful and unbiased report, irrespective of the affiliation of instructing party.

The majority of these cases have been settled without the need for trial. However, I have provided evidence in court and would be prepared do so again if necessary.

I am usually able to provide a report within four weeks of receiving the relevant medical notes. If required, I am able to review patients in consulting rooms in Birmingham, but increasingly have reviewed patients via Zoom or other remote platforms.

My fees are available on request, along with my T&C's. I do not charge for email exchanges or minor amendments. No conditional claims (no win no fee) cases are undertaken..
