This job involves looking after a variety of mental conditions with mix of emotional, behavioral and cognitive issues. I was also the ECT Lead Clinician for St Andrews Healthcare.
- My previous job as a Consultant Neuropsychiatrist was at the Burden Centre of Neuropsychiatry, Frenchay Hospital in Bristol. This job along with similar previous experience gives me expertise in Brain Injury, Epilepsy, Sleep Disorders, Somatisation (Medically Unexplained Symptoms), Early Onset Dementias (before age of 65), Huntington's disease, Tourette's syndrome (severe tics) and memory problems in general.

I have regularly seen parents with mental illness during clinical practice and have prepared reports for Child and Family courts for the same.

I currently work part-time in a low secure complex care service with St Andrews Healthcare Birmingham.

I have worked in a medium secure setting and in a bail hostel (approved premises). I regularly visited prison settings and have prepared reports for the criminal courts during training as a Consultant and as an Expert Witness. I was Consultant in a psychiatric intensive care unit and more recently in a locked rehab ward for male mentally ill offenders, many of them under Hospital and Restriction Orders in addition to civil sections of the Mental Health Act. I regularly prepare reports for the Ministry of Justice and Mental Health Review and Managers panels (around two per month).
