Full-time Business Career 1968 to 2013

During my full-time business career I worked for multinationals, plc's private and family companies and SME's in a wide range of industries including:

Part-time and non-executive business career 2013 to present

At the end of 2013 I retired from full-time work and initially took up a part-time non-executive position with Seamark plc a £100m international conglomeration of businesses in the food service industry for whom I had been CFO until my retirement. In this role I have acted as an advisor to the directors on strategy, governance and their private financial affairs and in particular was involved in:

- Restructuring the group to improve tax effectiveness and facilitate future exit

- Improving the governance of the business through the introduction of performance reviews and formalised meetings
- Improving the returns to the Directors' Pension Fund through restructuring and strategic asset acquisition
- Preparing strategic plans to address the issues arising from the 2016 referendum

In 2017 I took up a position of trustee/director for a newly formed multi academy trust to provide it with commercial and business advice

In 2019 I established my own accountancy practice Tailored Accounting Solutions to provide individuals and small businesses with advice and accounting services and to provide forensic accounting services to the legal profession and related activities

In 2007 and 2008 I worked as a part time lecturer for Stoke on Trent College preparing and presenting material to mature students studying for professional qualifications and financial appreciation courses for businesses and performed a similar role for St Helens College in 2013.
