## **Clinical:**

### **Neurological Rehabilitation:**

I lead a multi-disciplinary team managing patients who have had a recent onset of neurological illness or injury based at the Neurological Rehabilitation Unit in Neath Port Talbot Hospital, South Wales. Conditions managed on unit include traumatic brain injury, subarachnoid haemorrhage, hypoxic brain injury and cerebral infections such as meningitis and encephalitis. The team uses comprehensive assessment and a thorough goal planning approach to optimise functional outcomes in patients with complex neurological disability.

My other responsibilities in Neurological Rehabilitation include running Outpatient and Spasticity management (Botulinum toxin) clinics, community visits and working with the community based brain injury team. I have been involved in setting up services such as the Functional Electrical Stimulation (FES) service for patients with drop foot.

### **Amputee Rehabilitation:**

I run an Amputee Rehabilitation clinic for patients following a major limb amputation.

### **Other activities**

I regularly organise teaching and training for doctors, nurses and other health professionals involved in Neurological and Amputee Rehabilitation.
