- 8. Availability:** The waiting time for examination for personal injury non-urgent medical legal matters is approximately one month. I am prepared to try and see patients for consultation at short notice, if time allows. This must be done through personal negotiation with the solicitor or insurance organisation. Photographs are nearly always taken at the time of the consultation and the cost incorporated in the fee for the report. The current waiting time for reports from review of medical records only is approximately 3 months. I am willing to make prison visits and travel to see patients at home if they are disabled.  
**NB: Waiting times may change due to COVID restrictions.**
- 9. Fees:** Personal injury report fees average £500-£750 + VAT per report, based on a fee scale of £250 + VAT per hour of work. Medical negligence report fees average £900 - £2,500 + VAT based on a fee scale of £300 + VAT per hour of work.  
I expect payment of fees within 12 months or conclusion of the case, whichever is sooner. Interest will be charged for late payment after 18 months (unless further delayed payment has been agreed) under the meaning of “Late Payment of Commercial Debts (Interest) Act 1988.”
