I undertake a number of different types of evaluation. All of these involve use of psychometric testing. What follows is a description of each type. In the past three years, I have provided over 200 reports for Court purposes. 90% of these have been for the Family Courts and 90% of those reports have been joint instructions. I give oral evidence in approximately 40% of my cases.

1. Diagnostic Evaluations: These are usually done for colleagues or other mental health professionals when treatment planning questions arise. The battery of tests used usually includes: An intelligence test (often one of the Weschler scales), the Minnesota Multiphasic Personality Inventory - 2 (MMPI-2), the Rorschach test, the Thematic Apperception Test, a variety of self-report symptom tests depending on referral question (For example:

Neuropsychological screening in the case of possible biological disorder, Beck Anxiety Inventory in the case of suspected anxiety disorder, Beck Depression Inventory in the case of suspected depressive disorder.) In addition, the client is interviewed and a detailed history is taken, where possible previous treatment notes are reviewed. The report is usually 3 to 12 pages long and includes DSM - IV diagnoses and treatment recommendations.

2. Forensic and Medico-Legal Evaluations: These are done for family, civil and criminal cases - often at the request of either the defense or plaintiff's solicitor (in the case of criminal cases - sometimes at the request of the crown prosecution service. I have also done pre-sentence reports in the US and parole hearing reports as well as evaluation of competency to stand trial and insanity defense). I require specific referral questions and will help the solicitor to frame these questions if necessary. I will not do a limited report (e.g., give one symptom oriented test, interview the client and then offer an opinion). All forensic and medico-legal reports (including risk assessments) involve full and extensive psychometric testing as well as face to face interview. I require all medical/psychological/psychiatric records to be reviewed and also prefer to review all previous reports. In some cases, I may ask for corroborative evidence and to interview family members. Tests involved usually include: An intelligence test, the MMPI-2, the Rorschach test, the mcmi-iii. In the case of evaluation for PTSD, the following tests are also administered: The PENN Inventory, the Impact of Event Scale, Traumatic Stress Inventory. The rest of the testing depends on the referral question and suspected diagnoses. Clients can be seen at one of my office spaces (London, Tonbridge) or at their homes or other premises. I have travelled all over the UK (including Northern Ireland and Scotland) to conduct evaluations. I am able to give evidence on any report written. I will also consult with solicitors for background and general information on psychology as long as the area being discussed is one that falls within my specialties. Fee schedule available upon request.

3. Custody and access evaluations: I provide thorough evaluations of the whole family in cases of disputed custody and/or access. full evaluations involve a variety of psychometric tests for any adults involved in a custodial role as well as any children. limited evaluations are done in cases where there is not access to all adults involved in a custodial role.

I also provide evaluations and reports for industrial tribunals, criminal injuries compensation, and retirement and disciplinary boards. In addition, I review files for an overview of psychological issues in ongoing personal injury cases.

I have given oral evidence in the US and the UK. The oral evidence I have given in the UK has been in criminal and family cases. the rest of my cases (civil, criminal, and family) have all settled before trial or my evidence has been accepted by both sides.

I can provide psychological autopsy in cases of suicide and psychological/behavioural autopsy in cases of homicide, attempted suicide, as well as other violent crime. I also provide Risk assessment services in forensic cases.

I have particular expertise in detecting malingering of psychological or psychiatric symptoms in civil and criminal cases, risk assessment in family and criminal cases, Assessment of parenting capacity and ability to change and I assess children as well as adults. The risk assessments I perform include issues surrounding violence, sexual abuse, drug and alcohol abuse and dependence.
