Skills & Experience

I have been working in various psychiatric settings since 1993. I have been a Consultant Psychiatrist in General Adult Psychiatry in Southampton since November 2003. From November 2003 to December 2010, I worked as both a community and inpatient psychiatrist. From January 2011 to April 2013, I worked mainly as an inpatient psychiatrist, and within Crisis Resolution and Home Treatment Service, and thereafter as an inpatient psychiatrist.

I am currently a consultant psychiatrist for patients on acute wards. My work involves assessment and management of patients who suffer from acute, severe or enduring mental disorders, including psychotic, mood, personality and trauma/stress-related disorders, and drugs and alcohol misuse. Patients' conditions are often associated with other complex conditions/situations, such as forensic history (offending behaviour), violence, suicide attempts/deliberate self-harm, homelessness, immigration issues, and various general medical conditions. My work also includes assessment and management of patients who are treated with ECT. Detained patients under the Mental Health Act (MHA) make up between 50-60% of my patient group. I regularly take part in emergency and out-of-hours on-call: activities include assessment and treatment of patients in the community, police station, emergency department in the General Hospital. I am adept at all aspects of Mental Health Act, Mental Capacity Act and other legislations, including assessment, report-writing and attendance at Tribunals and Courts.

Expert Witness Practice

I have been undertaking independent medico-legal work since 2008. My expertise covers all aspects of General Adult Psychiatric conditions, Substance Misuse (drugs and alcohol related conditions) and Forensic Psychiatry including: Schizophrenia and other psychotic conditions; Depression and Bipolar disorder; Post-Traumatic Stress Disorder (PTSD) and other trauma/stress-related disorders; Personality Disorders; Anxiety and Obsessive Compulsive Disorders (OCD); Factitious disorders (Munchausen syndrome); Drugs & Alcohol problems; Risk assessment e.g. deliberate self-harm/suicide attempts, violence, self-neglect; Parental assessment; Mental Capacity assessment.

I have written numerous reports that are compliant with the relevant laws and procedures for the purposes of the Criminal, Civil and Coroner's Courts; Family/Children proceedings, Immigration proceedings; Fitness to Drive, Employment and Fitness to Practice proceedings. I have given expert evidence under cross-examination at the Courts and Tribunals.

I regularly undertake academic and professional activities to maintain and improve my skills and expertise. I have relevant knowledge of the Laws and Practice Directions in relation to criminal and civil litigations, family proceedings, immigration proceedings and other legal framework; and I am experienced in writing court-compliant reports.

I am an Accredited Expert Witness, having attained the Cardiff University Law School/Bond Solon (CUBS) Civil and Criminal Expert Witness Certificates.
