Clinical Roles

NHS Practice

I have been a Consultant in Trauma and Orthopaedic surgery and as a Limb reconstruction surgeon working in Liverpool since April 2004 at the Royal Liverpool and Broadgreen hospitals. Since November 2019, when the two large Liverpool hospital Trusts merged creating the Liverpool University Hospitals Foundation Trust, I have been working at Aintree and Broadgreen hospitals.

Acute trauma and limb reconstruction work

This takes place at Aintree Major Trauma centre, which is the main site in Merseyside delivering complex trauma care. Within my subspecialty interest as a Limb Reconstruction Surgeon, I treat patients with complex periarticular fractures of the lower limb, open fractures including limb threatening injuries, fractures associated with bone loss, periprosthetic fractures, patients with multiple injuries and acute osteomyelitis.

Elective work

At Broadgreen Hospital, I treat patients with post-traumatic complications such as non-unions (fractures that fail to heal), malunions (fractures that healed causing deformity), bone and implant related infections, joint contractures.

We have a dedicated standalone ward for Limb Reconstruction patients with an annexed dedicated physiotherapy gym where we believe high quality multidisciplinary care is provided.

The reputation of the [Liverpool Limb Reconstruction Service](#) is such that we receive tertiary referrals from other hospitals in Merseyside, from Lancashire, Greater Manchester, Cumbria, the Isle of Man, North Wales and we have patients seek care from us from other parts of the country.

Non-Clinical Roles

Honorary Lecturer Department of Medical Sciences University of Liverpool

I am regularly invited on providing lectures in courses and teaching sessions by the University of Liverpool in the field of orthopaedic surgery and trauma.

Maybe the biggest group of orthopaedic and plastic surgeons in the country collaborating in the provision of complex trauma and limb reconstruction care. We run a forum for discussion on clinical cases and we aim to coordinate and improve Ortho-Plastic care in open fractures, severe injuries and infection in Merseyside.

Former Executive Committee Member British Limb Reconstruction Society (BLRS)

This was a great honour and recognition for me. I was elected by the society members on this position in 2018. It allowed me to contribute on improving the organisation and care provision in limb reconstruction surgery. I stepped down from that role in 2022, to focus more on my clinical work.

Appraiser at Liverpool University Hospitals NHS Foundation Trust

Since September 2023 I have been an appraising of consultants and junior doctors not in training posts. The yearly appraisal for is a GMC requirement. This is an important role on assessing and on supporting doctors to reflect yearly on their achievements, performance and safety.

Orthopaedic Training

University of Verona Italy, Training Program in Trauma and Orthopaedic Surgery.

(October 1997-November 2002)

The programme is run by one of the foremost universities in Italy. The Orthopaedic Department of the University of Verona (based at the Policlinico Hospital) has an international reputation for trauma surgery and limb reconstruction. In addition to getting a broad foundation in general adult and paediatric Orthopaedics, my training there focused on Orthopaedic trauma, including the management and surgery of multiply injured patients, open limb injuries and complex peri- and intra-articular fractures. In this period, I gained experience in non-operative and operative techniques of trauma care, with special emphasis on minimally invasive methods. The Orthopaedic department at the Policlinico University Hospital was renowned for introducing at its time innovative practice changing methods involving unilateral external fixation techniques in trauma and limb reconstruction. The unit then was at the forefront of the concept of “damage control trauma surgery”.

This experience during my residency programme encouraged my interest in complex trauma and limb reconstruction.

Fellow in Limb reconstruction at the Royal Liverpool and Broadgreen University Hospital and Alder Hey Children’s hospital U.K. (October 2001-July 2002).

This position has broadened my experience in the field of trauma and limb reconstruction. I was a Limb reconstruction fellow under the supervision of Mr Selvadurai Nayagam who is one of the most respected Limb reconstruction Surgeons in the UK and Internationally. I was exposed to the use of circular external fixators for trauma and deformity correction, bone infection, non-union surgery and limb lengthening surgery. I was also introduced in a team approach to the delivery of care for complex trauma, involving specialist nurses, therapists and medical staff from other disciplines (notably Plastic Surgery, Radiology and Medical Microbiology). My Fellowship has been further enhanced by my involvement in research.

Fellow in Trauma Surgery, Royal Liverpool and Broadgreen University Hospital, U.K. (March 2003- June 2004)

I had the opportunity to work for a year as a trauma fellow in one of the busiest trauma units in the Northwest of England.

During that period, I was able to refine my knowledge and surgical skills in complex trauma including managing patients with multiple injuries, open fractures, complex periarticular fractures. I improved my knowledge in managing complex hip fractures, and periprosthetic fractures

Consultant in Orthopaedics and Trauma, Royal Liverpool and Broadgreen University Hospital, U.K. (Locum position from 2004-2007). Since 2007 I was appointed in a substantive role.

The early years have contributed on my further development as a trauma and limb reconstruction surgeon. In addition to my clinical practice, I took on a variety of non-clinical roles such as that of a rota master for junior doctors and Consultants, the role of consent lead for the department, Map of Medicine lead, Enhanced recovery lead.

Visiting surgeon Department of Trauma Surgery, Hand and Reconstructive Surgery, St. Vinzenz- Hospital, Cologne, Germany. (March 2005).

This was a visit aiming to provide me with exposure in novel techniques of management of complex injuries of the elbow and wrist, as well as managing post-injury joint stiffness, particularly at the wrist and elbow. The leading surgeon at the unit, Professor [Dietmar Pennig](#), has pioneered several innovations in the field of trauma. The Pennig method of treatment of elbow stiffness has been introduced in the Royal Liverpool and Broadgreen University Hospitals after our visit in Cologne and has benefitted many patients with severe injuries and post-traumatic stiffness. I had also the opportunity to learn from Professor Penning and Dr [Konrad Mader](#) who is an extremely gifted and innovative upper limb surgeon a variety of novel techniques in upper limb trauma. and gain exposure on the use of implants such as fragment specific plates in the wrist and elbow designed by these surgeons. I had exposure to their advanced techniques well before they went to become popularised widely in trauma surgery in specialist centres. With Dr Mader we have continued a

collaboration with exchange of visits between our units and invitations for lectures on International scientific meetings.

Visiting Surgeon Program Campbell Clinic, Elvis Presley Level 1 trauma Center, Memphis, Tennessee, USA. (Oct-Nov 2005)

This is one of the premier Orthopaedic and Trauma units in the USA. I attended under the tutelage of [Professor Emeritus Thomas Russell](#), who is an ex [Orthopaedic Trauma Association](#) president, one of the greatest innovators and respected Trauma oriented Orthopaedic surgeons in the world. I learned a lot from him in the use of internal fixation techniques for long bone and peri-articular fractures. I also gained exposure on modern techniques in the management of pelvic fractures.

Visiting Surgeon Program Trauma Surgery Department, Bergmannsheil, Uniersitätsklinik, Bochum, Germany (Jan-Feb 2006).

[Bergmannsheil](#) is the world's oldest and also the largest emergency hospital. I undertook a secondment with one the busiest trauma units in Europe. The exposure I had there increased the breath of my knowledge in management of polytraumatised patients, pelvic injuries and periprosthetic fractures in osteoporotic patients.

Visiting Surgeon Program [Universitätsklinikum Münster](#) Germany (Sept-Oct 2023).

This is one of the busiest units in Europe using extensively motorised intramedullary lengthening nails. I have expanded my knowledge on the use of such devices for lengthening and deformity correction and reinforced some of the aspects of our current practice in Liverpool vs theirs.

Visiting Surgeon Humanitas Institute Milan, Italy

I visited a center of excellence in managing complex hindfoot deformities and limb reconstruction lead by [Dr A. Kirienko](#) who is a hugely experienced and widely respected surgeons using the [Ilizarov method](#) on gradual and acute corrections of the lower limb and foot and ankle with the use of circular fine wire fixators.
