April 2024 to date: Having retired from full-time NHS work as Consultant in Obstetrics & Gynaecology with Special Interest in Fetal Medicine, I am now a 'Freelance' consultant, doing short-term NHS work, along with my medico-legal expert witness work.

***Clinical Experience. My extensive clinical experience includes:***

I have a long track record of distinguished individual and teamwork, based on self-motivation and full respect for all levels of colleagues, with the aim of achieving quality care for all in our care. This is supported by 360 feedbacks over the years.

I am certified for Advanced Obstetric Ultrasound and have a Special Interest in Fetal Medicine. I have over 20 years of secondary care Fetal Medicine experience, covering a wide range of fetal conditions. My publications include contribution to a reference book on obstetric ultrasound (see publications section).

My Gynaecology experience includes hysteroscopy, endometrial ablation and other minor diagnostic and therapeutic gynaecological procedures. Intermediate and major procedures include diagnostic laparoscopy, intermediate operative laparoscopy, abdominal hysterectomy, vaginal hysterectomy, pelvic floor repair, laparotomy for benign pelvic conditions and myomectomy. This list is not exclusive.

My Obstetric procedures experience include cervical cerclage, external cephalic version (ECV), fetal blood sampling, instrumental birth procedures, including Kielland's rotational forceps; complex Caesarean Sections, including for morbidly adherent placenta; uterine tamponade procedures, B-Lynch suture, Caesarean hysterectomy. This list is also not exclusive.

Key clinical diagnostic and treatment procedures/devices I introduced into practice in York include: Actim Partus, Actim PROM, Fetal Fibronectin, Propess, Episcissors 60 and Cook Cervical Dilator balloon. All of these were preceded by business case/applications for introducing a new procedure/equipment and followed by audit of effectiveness after establishing clinical use.
