eyelids), cosmetic eyelid surgery (blepharoplasty), revision blepharoplasty, brow lift surgery, eyelid

and orbital trauma including orbital fractures, eyelid and orbital tumours, eyelid reconstructive surgery,

enucleation/evisceration (removal of an eye), eye socket reconstructive surgery following loss of an

eye, thyroid eye disease, essential blepharospasm, the watering eye and its surgical management, eyelid

and upper facial surgery for facial palsy, facial botulinum toxin injections, facial dermal filler injections

and the management of associated complications. I also have expertise in the diagnosis and

management of general ophthalmic disorders.

In addition to my general ophthalmic training, I undertook specialist training in oculoplastic surgery at

Moorfields Eye Hospital, London, in 1989 and then undertook further specialist training in oculoplastic,

orbital and lacrimal surgery at the University of Iowa Hospitals & Clinics, Iowa City, Iowa in 1991.

This was a 12-month intensive training fellowship with exposure to all aspects of oculoplastic, orbital

and lacrimal surgery.

I also spent a great deal of time training with plastic surgeons, ENT surgeons, neurosurgeons and

maxillofacial surgeons during the course of my fellowship in the USA. I worked closely with colleagues

in these specialties for over 20 years gaining further experience of their surgical approaches to the

management of a wide range of disorders. I was the preceptor for an oculoplastic and orbital sub-

specialty training fellowship at Manchester Royal Eye Hospital for over 20 years. I have trained

surgeons from Australia, New Zealand, India, Pakistan, Europe and Israel in addition to surgeons from

the U.K.
