My fees are £250 per hour, payable within three months of receipt of my completed report. I'm happy to have a brief free discussion by phone, or e-mail, on the merits of the case prior to a decision on whether to instruct. I will provide an estimated maximum fee in advance, so that those instructing know their maximum financial commitment. I can normally see clients if needed within one month of instruction. I aim to provide a report within three months of seeing the client and/or receiving

the documents, whichever is later. If there is a simple correction required, I'm happy to provide this free of charge. If there are further documents/questions to consider, or addendum reports required I will charge at £250 per hour.

If I provide an initial overview report at a fixed fee, based on a time limited assessment of documents and subsequently a definitive report is required with more detailed assessment, further charges will be incurred at £250 per hour for the additional work involved.

Medical records are ideally provided by secure login to your server, good

indexing is appreciated and will save time (and therefore cost). Alternatively, paper files are acceptable, I do not accept records on CDs.

For expert conferences, I prefer these to be telephone/video conferences if possible; I charge £250 per hour for the conference itself and the time spent in preparation. If required to attend in person, then I charge £100 per hour for the time spent travelling, plus the cost of travel,

in addition, to the time spent in preparation and attendance at £250 per hour.

If there are special circumstances e.g. particular urgency, I'm happy to be flexible whenever possible. It is helpful to know at the outset so that if

I cannot meet a deadline, I can let you know straight away.
