I have been in medicolegal practice from 2002.

I hold a post-graduate diploma with commendation in Medical Law, and maintain regular medicolegal CPD.

I am the co-editor of the Lower Limb Section in the next edition of Foy and Fagg's Medicolegal Reporting in Orthopaedic Trauma.

Most of my reports are now on complex fractures and serious injuries.

Clinical Experience

I have been a full-time Consultant in Orthopaedic Trauma and Limb Reconstruction from 2002. I continue to be in full-time practice in both trauma and elective orthopaedic surgery.

My specific area of acute trauma expertise is in treating *multiply injured patients*, complex fractures of both upper and lower limbs, open fractures, and the use of *external fixation devices* such as Ilizarov frames and Taylor Spatial Frames.

I carry out *limb lengthening, deformity correction*, and regularly treat *osteomyelitis* in both upper and lower limbs.

I treat complications of fractures such as *nonunion, malunion, Fracture Related Infection, joint stiffness and contractures*.

I have a specialist tertiary practice in reconstruction of *foot and ankle problems after neurological injury*, after complications of diabetes, and in the treatment of *complications after amputation surgery*.

I am an Examiner Assessor for the Intercollegiate Board, and for the International Surgical Board.

I was previously an intercollegiate examiner, Training Programme Director for orthopaedics, member of the Specialist Advisory Council, and part of Council of the British Limb Reconstruction Society.
