EXPERT WITNESS TRAINING

I have attended expert witness skill courses over the last few years and have gained expert skills in report writing and giving evidence in courts. On the Cardiff University Law School and Bond Solon Expert Witness Skill courses between 2012 and 2013, I gained competencies in various modules including 'excellence in report writing', 'witness familiarisation', civil procedure and law, criminal procedure and law, and family procedure and law etc.

MEDICO-LEGAL EXPERIENCE

I have been preparing medico legal reports for courts since 2003. I provide approximately 100 reports annually in both criminal and civil cases for solicitors, CPS, Courts, occupational health physicians and insurance agencies. I have given oral expert psychiatric evidence in courts on numerous occasions in relation to fitness to plead and stand trial, criminal responsibility, dangerousness, partial defences to murder in murder trials and in relation to the imposition of restriction orders (section 41 of MHA 1983) on dangerous mentally disordered offenders. I have given expert psychiatric evidence in magistrates, county courts, the High Court, the Crown Court and at Parole Board hearings and mental health tribunals.

My training and study for the LLM in Mental Health Law and the MA in Medical Ethics and

Health Care law have equipped me to prepare medico legal reports of high quality and to the highest ethical and professional standards in accordance with the Civil Procedure Rules (CPR) and Criminal Procedure Rules (CrPR).

An increasing proportion of my work has come in recent years from the Defendant, so that the ratio is now around 65:35 in favour of Claimant work. In addition, many instructions are now on a single joint expert basis.

I prepare expert psychiatric reports in the following areas:

- **Criminal:** Fitness to be interviewed, reliability of police interview evidence, reliability of complainants/witnesses, fitness to plead and stand trial, trial issues (including intent, criminal responsibility, insanity, automatism, duress, provocation, diminished responsibility), sentencing issues (including diagnostic and treatment suitability issues, risk assessment, disposal under the Mental Health Act 1983 and community sentences; Parole Board reports.
- **Civil:** Psychiatric sequelae of road and industrial accidents and other traumatic experiences, such as medical negligence, including post-traumatic stress disorder, psychosomatic disorders, depression/adjustment disorder and anxiety disorders, diagnosis and care reviews, bullying and harassment, exaggeration of symptoms
- **Historical Sexual Abuse Cases:** I have dealt with many historic abuse cases and I am assisting in several group actions at present
- **Capacity Assessments:** Including testamentary capacity
- **Employment Law:** Occupational assessments, disability discrimination, employment stress, personal injury in Employment Act cases
- **Independent Psychiatric Reports:** Mental Health Tribunals (MHTs) and other second opinions. Parole board reports and attending parole hearings
- **Family Law:** Parental assessments in childcare proceedings
- **Asylum seeker/immigration cases:** Psychiatric assessments to consider the impact of trauma, sexual abuse and malingering
- Advice to independent bodies such as Citizens Advice Bureau or trade unions on individual cases.

AREAS OF EXPERTISE AND SPECIAL INTEREST

Assessment and treatment of mental disorder particularly post-traumatic stress disorder, psychiatric sequelae of head injury, affective disorders including depression & bipolar disorder, anxiety, obsessive compulsive disorder, alcohol and drug dependence, mentally disordered offenders, psychopharmacology (particularly in relation to violence and aggression), women's issues relating to psychiatry, medical ethics and health care law, mental health law,(in particular, in areas related to the MHTs, the Human Rights Act, capacity and consent to treatment).
