I have worked in the automotive industry for over 20 years during which time I piloted a litigation department for a leading car hire company. I have worked in the care sector assisting individuals with both mental and physical needs under the Mental Health Act and Mental Capacity Act.

My experience working with Personal Mobility Solutions since 2018 includes providing personal transport assessments for clients with a variety of disabilities and requirements on a treating and consulting basis, including Expert Witness transport reports and Part 35 instructions. Client referrals are via their legal representative, case manager or occupational therapist.
