Professional qualifications: I qualified MB ChB at Leeds University in 1986. I became a Member of the Royal College of Physicians of London (MRCP) in 1989 and a Fellow of the Royal College of Anaesthetists (FRCA) in 1992. I was granted Foundation Fellowship of the Faculty of Pain Medicine of the Royal College of Anaesthetists (FFPMRCA) in October 2007. I was elected to Fellowship of the Royal College of Physicians (FRCP) in May 2009.

NHS Consultant appointments: I was appointed Consultant in Anaesthetics and Pain Management at Norfolk and Norwich University Hospital in October 1996. From September 2001, my NHS practice was dedicated to pain management, which continued until March 2016 when I left to pursue new challenges. The Norwich Pain Management Centre provides a multidisciplinary service with doctors, nurses, clinical psychologists and physiotherapists.

Private practice: I have held pain management clinics at Spire Norwich Hospital since 1997.

Experience: I am experienced in the management of a wide range of chronic pain conditions, including those resulting from personal injury and clinical negligence.

Presentations: I have presented and chaired sessions at national meetings of the Royal College of Anaesthetists, the Faculty of Pain Medicine, the British Pain Society, and the Neuromodulation Society of UK and Ireland. I have taught interventional pain techniques at the Leeds Cadaver Course since around 2010. I have also presented to lawyers, insurers and the NHS Litigation Authority.

Pain Expert Limited: I established Pain Expert in November 2012. This limited company currently employs seven staff to run an office and primarily offers the medicolegal services of experienced pain management specialists, but also the medicolegal services of other specialists including anaesthetists, psychiatrists, and pain management psychologists.

Medicolegal report writing experience: I have prepared evidence for the Court in matters of personal injury and medical negligence for around 25 years. I currently typically prepare three or four medical reports each month. Most reports relate to the more complex presentations of chronic pain associated with significant functional impairment. The ratio of my medicolegal instruction has varied over the years. Since December 2016, my claimant/defendant ratio has been maintained close to 50:50.
