I am a Consultant in Pain Management and Anaesthesia at Salford Royal Foundation Trust which is a teaching hospital of the University of Manchester and Trauma Centre for Greater Manchester. The

Manchester and Salford Pain Centre uses interdisciplinary assessment involving healthcare professionals from differing disciplines and professions including physiotherapy and psychology that

provides rehabilitation and interventional pain management.

I have a wide experience of Pain Management and Anaesthesia and my training included a

fellowship in Pain Management at the Manchester and Salford Pain Centre at Hope Hospital. I have previously been the clinical lead for the inpatient pain services. I was the Clinical Lead of the Pain

Centre for 10 years. I am the Chair of the Surgical Neurosciences governance committee.

I specialise in the assessment and treatment of all pain syndromes including the management of

post-operative pain. I work in a multi-disciplinary team specialising in the out-patient management of many chronic pain syndromes, including back pain, whiplash, complex regional pain syndrome,

fibromyalgia and neuropathic pain. I am involved in managing chronic pain with medication,

injection therapy, pain management programmes and neurostimulation.

I provide pain opinion for inpatient pain problems including following trauma, back pain and patients

with flare up of chronic pain conditions. I provide advice for the pain problems on the gastrointestinal failure unit at Salford Royal which is one of two nationally funded units in the UK.

My anaesthetic practice covers anaesthesia for orthopaedic, general surgery, ENT and gynaecology.

I take part in an on call rota that also includes neurosurgical cover. I was the Lead for establishing

our department as accredited by the Royal College of Anaesthetists for our anaesthetic services.

I have been involved in medico-legal work for over 20 years.

I have co authored a chapter on clinical negligence occurring in anaesthesia.
