Career Summary

I have 20 years' experience as a Forensic Document Examiner, having worked at both Police and private laboratories before becoming a self-employed expert consultant. Throughout my career I have worked alongside many of the most experienced experts in the UK.

I have examined more than 1000 cases from private and corporate instructions together with civil and criminal matters as instructed by government departments and legal advisors, including cases where I have acted as a Single Joint Expert. I have also provided evidence for enquiries into media personalities and politicians, including magisterial inquiries in Malta.

I have given expert evidence at court on many occasions, attending magistrates, crown and county courts all over the UK in person and have also provided evidence remotely in the UK and abroad, including the Royal Courts of Justice in London and the Coroner's Court in the Cayman Islands.
