WORK EXPERIENCE

Present

I am currently engaged in independent Chartered Clinical Psychology work in a variety of settings.

These include:

- Completion of a variety of Court assessments and reports addressing clinical issues in cases relating to divorce/separation, custody, deportation, permanence/adoption, contact, trauma, sexual abuse, child interviewing and testimony, and personal injury.

To date I have been instructed to provide more than 600 reports and have been called to give evidence in Court of Session, High Court, Sheriff Court and before Children's Panels and Hearings.

- Assessment and direct therapeutic work, with children, adolescents and young adults addressing a wide variety of psychological presentations.
- Provision of training and presentations on issues relating to child contact disputes, historical sexual abuse, domestic abuse, adolescence, adoption and post permanence contact, and vulnerable witnesses. Prior presentation venues include the Judicial Institute of Scotland, Judicial Studies Institute of England, Faculty of Advocates and professional psychological, fostering/adoption and legal conferences.

I am Chartered by the British Psychological Society, an Associate Fellow of the British Psychological Society, and am registered with the Health and Care Professions Council who monitor and maintain standards of CPD.

October 2002 - October 2004

Clinical Psychologist with Fife Primary Care Trust (Full time Oct 2002-Nov 2003; Part-time Dec 2003-Oct 2004)

This post was within the Child and Adolescent Clinical Psychology Service based at Playfield House, Stratheden Hospital, Fife. This post involved sessional work within clinics in the west of Fife, providing assessment and intervention to young people under the age of eighteen presenting with a wide variety of psychological and behavioural difficulties.

Until going on maternity leave in May 2003 I was also working with the Centre for the Vulnerable Child in Kirkcaldy providing therapy and support to young people from throughout Fife who have experienced sexual abuse.

October 1997 - September 1999:

Research Fellow at the University of Portsmouth.

This was a 2 year post working on a Leverhulme funded project investigating verbal and non-verbal cues to deception, and the ability of others to recognise these cues. During this time I also gave guest lectures on the dynamics and aftermath of sexual violence and pre sented my Ph.D. findings at a number of conferences.

June 1997 - August 1997:

Postdoctoral post with the Environmental and Industrial Psychology group at the University of St. Andrews

1994 - 1997:

Support worker for the Dundee Rape Crisis Centre.

During this time I worked as a support worker for adult and young women who had experienced rape or child sexual abuse. This involved face-to-face support work, support during court and medical proceedings, and regular crisis telephone support. During my time at the Rape Crisis Centre I assisted in the development of the Young Women's Project which works solely with young women under 16 years of age and was elected to the DRCC Management Committee. Other duties involved attending ongoing training in a wide variety of skills, assisting in training of new volunteers and general assistance in the office.

EDUCATION HISTORY

1999 - 2002

Doctorate in Clinical Psychology at the South East Thames (Salomons) Training Scheme, Part of Canterbury Christ Church University College.

This clinical doctoral course provides training and experience in a wide variety of assessment techniques and therapeutic models. These include Cognitive Behaviour Therapy, Psychodynamic Psychotherapy, Narrative Therapy, Systemic Models and Integrative Approaches. In addition to core placement experiences in adult, child, learning disability and older adult specialties, I also enjoyed a year-long elective placement specialising in work with adolescents. This included assessment and intervention with clients in outpatient, inpatient, outreach, and family therapy settings.

For my doctoral dissertation I applied the qualitative technique of Interpretative Phenomenological Analysis to "An Exploration of the Identity Formation of Adolescents in Foster Care". Data was obtained from in-depth interviews with young people in foster care. At examination this dissertation was awarded a distinction.

I was also trainee representative on the Selection Committee for the Salomons training programme for the period 2001-2002.

1993 - 1997:

Ph.D. in Psychology at the University of St. Andrews, Scotland. Doctoral thesis entitled "Sexual Violence: Dynamics, Aftermath and Intervention".

This was an in-depth examination of the impact of assault characteristics, personal attributions and perceptions, and post-assault interactions on levels of trauma and the process of recovery from rape or child sexual abuse. Data collection involved wide-scale question naire sampling of the general public and detailed interviews with survivors. In addition, quantitative studies examining attitudes towards survivors of sexual and physical violence, and methods of education to counteract rape myth belief, were carried out to compliment the main body of the research.

1989-1993:

MA Honours degree in Psychology at the University of St. Andrews, Scotland.

During my degree I also took courses in Biology, Moral Philosophy, and Logic and Metaphysics. My Honours Psychology project was an examination of spatial memory in preschool children.
