Clinical Profile

I am a Consultant Urological Surgeon at Sheffield Teaching Hospitals. I have a specialist interest in urinary tract reconstruction and receive personal regional and national tertiary referrals. My areas of specialist expertise are in the treatment of urethral strictures, complex incontinence, urinary fistula, refractory bladder problems and urinary tract injuries arising from trauma or surgery. I also have a busy practice in general urology.

Medico-legal Profile

I have a longstanding interest in the medico-legal issues in urology. I have undergone training in medico-legal report writing. I keep up to date with medicolegal developments. I am aware of the requirements of Part 35 and Practice Direction 35, the Protocol for the Instruction of Experts to Give Evidence in Civil Claims and the practice direction on pre-action conduct. I published the first national analysis of urological litigation in the UK (Osman NI, Collins GN. Urological litigation in the UK National Health Service (NHS): an analysis of 14 years of successful claims. *BJU Int* 2011; 108: 162-5). This has become the most widely cited work on the topic. I receive approximately 100 instructions for personal injury and clinical negligence cases on an annual basis for both claimant and defence, with an approximate split of 80:20.
