3. Current and previous posts

- I started my role as a Neuropsychiatrist at Walkergate Park, Centre for Neurorehabilitation and neuropsychiatry, Newcastle on 09.03.2017.
- Prior to this I worked as a Consultant General Adult Psychiatrist at Tranwell Unit, Gateshead which is an acute adult inpatient mental health unit from 09.02.2015 - 08.03.2017.
- I trained in the Northern deanery and completed basic and specialist training between August 2007 - January 2015 working various specialities of psychiatry including general adults, children, Older Age, Neuropsychiatry and forensic psychiatry.
- I completed certification of Training in General Adult Psychiatry in 2015.
- I completed Membership of the Royal college examination in Psychiatry in 2011.

4. Experience of expert witness

- I have experience of preparing expert witness court reports for civil and criminal cases, medical negligence cases from 2011, providing neuropsychiatric opinions, psychiatric opinions, fitness to plead reports and opinions on insanity defence.
- I have provided Court reports for defence, prosecution and joint instructions. I remain objective in my opinion irrespective of where the instruction comes from and strictly follow that my duty is to The Court in supporting the Judge and Jury in their decision making.
- I provide impartial reports on clinical negligence cases after assessing and reviewing evidence thoroughly.
- I analyse and evaluate evidence relevant to the case to provide insight on the evidence presented and its implications to the case. I have demonstrated this in a number of cases but of particular interest to me is a case of brain injury from bombing and patient with Functional Neurological Disorder.
- I prepare Section 49 reports on behalf of CNTW NHS Foundation Trust for Court of protection issues.
- I provide Court of protection reports assessing and providing opinion on capacity to make decision about care, treatment, residence, finance and other complex issues that may arise.
- My claimant: defendant: joint ratio is approximately 65:25:10 currently.
- I provide second opinion and advice to Neurologists, psychiatrists win complex Neuropsychiatric presentations. I also provide expert opinion on patients with complex neuropsychiatric conditions on long term placements for challenging behaviour.
- My strength is my clinical expertise in General Psychiatry with specialisation in Neuropsychiatry that gives a comprehensive understanding of issues and their implications. I evidence my opinions using latest literature and support my findings with appropriate cognitive and psychiatric assessment scales.
- I complete approximately 24 reports per year and attended trial to give evidence on six occasions.

5. Clinical Experience:

Outpatients

- I assess and manage patients with neuropsychiatric conditions in traumatic brain injury, metabolic and hypoxic brain injury, auto immune encephalitis, herpes encephalitis and various other conditions. I also provide neuropsychiatric care for patients with Parkinson's disease, Huntington's disease, epilepsy, post stroke, brain tumours, Tourette's syndrome, post brain surgery, alcohol relate brain damage etc.

Inpatients:

- I look after inpatients with Huntington's disease, brain injury, post traumatic amnesia and responsible for assessing and managing their Neuropsychiatric conditions. As

Consultant for Neurobehavioural rehabilitation ward, I have been leading the team providing inpatient rehabilitation for post-acute rehabilitation following brain injury managing rehabilitation, neuropsychiatric sequelae of brain injury and challenging behaviour with excellent outcomes.

- My day-to-day role involves appropriate use of Mental health act and Mental capacity act, capacity assessment and best interest decisions on care and finances.
- I am approved under Section 12 (2) of the Mental health act 1983 (amended 2007).
- I provide occupational health reports, fitness to drive reports.
