I have experience of prior working as a Consultant Orthopaedic Surgeon in Ireland for more than 5 years (2007 -Nov 2011) doing complex upper and lower limb trauma, polytrauma and general orthopedics.

I did a fellowship in paediatric orthopaedics and limb reconstruction from Sheffield Children's Hospital in 2006.

I have extensive breadth and extent of experience through various subspecialties of Orthopaedics having completed my orthopaedic training in UK, Eire, and India.

I did a six-year comprehensive structured training programme including M.S (Orth) followed by three years of senior residency (lecturer) in teaching university hospital in New Delhi, India.

I am also an ATLS instructor.

Medicolegal Experience.

I have been providing expert reports since 2006 in the areas of pediatric trauma and conditions, non-accidental injuries in children, polytrauma, multiply injured complex patients, general trauma, specialist interest in upper limb trauma, hip fractures along with areas of clinical negligence in the above areas for both claimants and defendants and work-related injuries and disorders for both claimants and defendants .

I have been doing medico legal work in Ireland since 2006 for Injuries board and solicitors and in UK since 2011 and have done more than 7000 reports between UK and Ireland. I have attended courts for providing expert evidence in Ireland and UK and in cases of non-accidental injuries in children as combined instructions as well as the councils.

I have been on the panel of Personal Injuries Assessment Board in Ireland since 2006 which provides independent reports (similar to combined instructions in UK)

I have been doing medico legal reports since 2007 in UK and Ireland for solicitors' and Insurance companies like AXA, RSA, FBD and LIBERTY insurance, AVIVA, ALLIANCE in complex cases, critical injuries compensation authority, combined instructions in complex cases, PIAB in Eire (personal injuries assessment board)

I also provide reports based on clinical negligence claims in the UK on multiple occasions.

I have experience of attending court as an expert witness both in UK and EIRE and have made many joint reports in consultations with other parties
