Medico-Legal:

I have been writing reports on personal injuries claims since March 2014.

I was honoured with the 'Trauma and Orthopaedics expert of the year award' in 2020 and 2023. My turnaround time for a report is about 3 weeks. I write approximately 200- 250 personal injury reports per year.

I started writing clinical negligence reports in August 2015 and now usually complete about 30 to 35 clinical negligence reports in one year. This includes breach of duty/ causation and condition and prognosis reports. I have not yet been asked to give evidence in person in court. My claimant: defendant ratio is about 90:10.

Medical Interests and specialties:

My primary interest is orthopaedic trauma. I specialise in management of pelvic and acetabular fractures, complex periarticular upper and lower limb injuries, management of the multiply injured patient and chest trauma. I was instrumental in setting up rib fracture fixation service at University Hospitals, Coventry and Warwickshire in collaboration with the thoracic surgeons. I am an active member and former treasurer of the Orthopaedic Trauma Society. Since 2014, I have been an instructor on the AO Trauma fracture fixation courses. In my elective NHS practice, I perform approximately 40 primary hip and knee replacements each a year. I set up the ultrasound guided hip injection service at Coventry for patients with hip pain. In 2011 my colleague and I set up a website 'whichorthopaedicimplant.com' to help surgeons identify hip and knee prostheses from radiographic images.

Teaching Experience

I am a formally qualified teacher and take a keen interest in teaching medical students and surgical trainees. I am the lead for musculoskeletal sciences at the Warwick Medical School and have played an active role in redesigning the curriculum. I was awarded the Outstanding Service and Care Award (OSCA) for the year 2022 in recognition of my contribution to Warwick Medical School. Since 2023, I have been appointed to be on the panel of examiners for the FRCS exam for specialty of trauma and orthopaedics.
