#### **Overview of General Practice Experience**

I have been working as a full time NHS doctor for 25 years. My first 10 years were in hospital medicine where I worked at all grades including Consultant. I then began my career in General Practice and I have been a GP Partner in a thriving North London GP surgery for 14 years. I work 4 days a week in the GP surgery, typically undertaking 6 clinics a week. I qualified as a GP Trainer in 2013, and have continuously trained junior GPs since that time. This includes lecturing on the Royal Free Hospital GP training scheme programme.

Alongside my GP surgery work, I have enjoyed a number of portfolio roles in primary care:

Appraisal: 7 years as a GP appraiser. Over 100 appraisals of GP colleagues completed. An appraisal is a detailed assessment of doctor performance relative to the General Medical Council standards of good practice.

Leadership: 15 years of Clinical Leadership roles. More recently, these have been Board and Director roles for local NHS health bodies (NHS North Central London Integrated Care System and the Islington GP Federation). I was elected to both these roles by fellow Islington GPs. My other clinical leadership roles have been in Information Technology and ENT/Audiology.

*Emergency Primary Care:* 6 years as Clinical Supervisor in emergency out of hours General Practice. I supervised and trained junior GPs working in the weekend and evening emergency GP service.

I have amassed a wealth of primary care experience including routine and emergency clinical care, clinical governance at all levels (practice, primary care network, GP Federations, Integrated Care System), healthcare transformation and digital innovation, healthcare procurement and commissioning, and education.
