### Introduction

I am a practicing Consultant Psychiatrist, on the GMC Specialist Register, and an Approved Clinician, with a special interest in Clinical Forensic Psychiatry.

My recent caseload for my Medico-Legal practice has included personal injury, employment law, disability discrimination, complex autism, OCD and chronic fatigue syndrome cases, medical negligence, assessment of capacity, fitness to plead, asylum application (including assessment of torture and abuse), automatism, joint enterprise murder, suicide, body dysmorphic disorder, as well as more general forensic and civil cases. I have produced reports for Family Court and the Court of Protection under Single Joint Expert instructions and for the UK Government. I have been instructed by both the General Medical Council, and the General Dental Council as an independent Expert Witness. Over the last few years, I have accepted instruction on some particularly complex cases, with evidence bundles of between 3,000 and 5,000 documents.

I produce reports for the Magistrate's Court, Crown Court, Coroner's Court, and Employment Tribunals and give evidence in Court.

I interview clients in consulting rooms in Harley Street, Central London, in their own homes, within the prison services, and in hospitals. I offer face-to-face or remote assessment, according to client preference and feasibility.

I am fully qualified in both Surgery and Psychiatry and am a Fellow of both the Royal College of Surgeons and the Royal College of Psychiatry. This breadth of experience lends itself particularly to producing reports on behalf of clients with complex co-morbidity and cases involving combined physical and mental health issues. For example, my oral evidence and written report submitted to the Senior Coroner (Inner London South) in the case of the death of a young woman whilst under psychiatric care, resulted in the Senior Coroner's request for a review by the Royal College of Psychiatrists and the Royal College of Physicians on the management of neuroleptic malignant syndrome; their joint revised Position Statement should result in improved patient safety.

I am currently the Responsible Clinician at Battersea Bridge House, 1 Randall Close, London SW11 3TG. Battersea Bridge House is a 22 bedded unit for both male and female adults with severe and enduring mental illness and additional complex behaviour. I was previously employed by The Priory Burgess Hill, (formerly Partnerships-In-Care), since December 2013, where I ran the Male Adult Acute Service, whilst providing on call cover to the male PICU, two female forensic wards, a female PICU and a personality disorder unit.

From January 2013 to November 2013, I was Responsible Clinician for the Cambian Group at Delfryn Lodge Rehabilitation Hospital in North Wales.

From May 2011, I was Consultant General Adult Psychiatrist for CNWL Hospital Trust at Northwick Park, where I was involved in the reorganisation to functionalised teams, whilst continuing to work with the Recovery Team as a full time Community Consultant. During my time at Northwick Park Hospital, I also ran weekly sessions as Consultant Psychiatrist at Colnbrook High Security Immigration Removal Centre for a six-month period, which included risk assessment and detox and methadone management.

#### Qualifications

I have a First-Class Degree in Basic Sciences, Neuropsychology and Developmental Psychology (1981). I qualified as a doctor in 1985 from Charing Cross-Westminster Hospital. I then went on to work as a surgeon and obtained my full FRCS (Eng) in 1993. I was awarded the 'Freedom of the City of London' by Mayor Sir Christopher Rupert Walford, in 1995 for exceptional service whilst covering Accident and Emergency.

After working in General Surgery, between 1994 and 2004, I went on to train in psychiatry. I obtained the Full Membership of the Royal College of Psychiatrists in 2006 and became Section 12(2) approved in 2007. I completed Psychiatry Higher Training in 2010 and entered the GMC Specialist Register for General Adult Psychiatry. In Higher Training, I pursued a special interest in Forensic Psychiatry and gained a Master's Degree in Clinical Forensic Psychiatry at Kings College, London, and the Institute of Psychiatry in 2010. I was elected as a Fellow of the Royal College of Psychiatrists in 2023.

I became an Approved Clinician in April 2011 and am a Fellow of the Royal Society of Medicine and a vetted member of the UK Register of Expert Witnesses.

## Updating

I update my skills base in both Forensic and Adult Psychiatry through attending relevant meetings and conferences; I regularly attend the weekly Maudsley Forensic meetings. I attend conferences, professional meetings, and the Gray's Inn Expert Witness Course. I keep up to date with CPD.
