I was privileged to be working as one of the inaugural Consultant Anesthesiologists of the Anesthesiology Institute at Cleveland Clinic Abu Dhabi. My position was initially to aid in the set-up of both the Institute and the Hospital at varying levels. Within my first weeks in this position, I became well established as the Linkman between EPIC, Site Support, Information Technology (IT) and the Anesthesiology Institute looking at the human factors element of the electronic medical record (EMR) system and the other software used to record a patient episode. I was able to put to good use my previous medical informatics and IT governance experience in helping to guide changes and lead the programming team from a clinical perspective. I was also one of the principle physicians directing my experience in patient safety issues in looking at various levels of communication within teams, how IT can help implement this, and the importance that this has with respect to patient centered care. I have attained a MSc in Cybersecurity in Health Informatics with distinction which has helped direct my IT practice.

As one of the inaugural physicians, I was tasked with writing many of the clinical Standard Operating Procedures (SOPs) and helping guide how the services of the Anesthesiology Institute developed over time. As a reflection of my excellent interpersonal and communication skills, I was the Employee Assistance Programme representative for our Institute and have been the lead physician in writing the Substance Abuse Programme policy for Cleveland Clinic Abu Dhabi.

Additionally, I am the Medical Director of Non-OR Anesthesia which requires the management of all remote areas where anesthesia is undertaken. This also involved managing a multi-million dollar anaesthetic commissioning in our cancer centre which went live in April 2024.
