Involved in departmental change; recruitment, development, assessment, training and related areas.
- June 2000 September 2003 (part-time): Head of Psychological Therapies at Oakview Adolescent Forensic Unit, Kent. Work with young people under 18 on Section of MHA(1983) with single or multiple diagnosis for severe and enduring mental health issues, as well as some acquired brain injury and Autism/ADHD/Severe Conduct Disordered young people. Member of SMT, and responsible for staff supervision, specialist training, and learning development as well as liaising with the Education Department in the provision of specialist programmes and projects for mentally-unwell young people.
- September 2001 May 2003 (part-time) East Kent NHS Mental Health Trust. Principle Psychologist in Adult Mental Health. Part of multi-disciplinary team, working with Social Service and voluntary sector colleagues in the delivery of mental health services to a large community in the Thanet area of Kent. Training workshops, staff supervision, group-work and service development were all part of my responsibilities, alongside working with adults with severe and enduring mental health diagnoses. My specialist areas were working with women who had had radical surgery, eating disorders, survivors of sexual abuse, and body dysmorphia, as well as severe anxiety, depression and OCD.
- July 2003 Dec 2010 Nottinghamshire Healthcare NHS Trust. Service Lead in North Nottinghamshire for CAMHS. Specialist post with specific responsibility for service development and services to fostered and adopted children and young people. Role included supervision of staff and students; service development; membership of relevant committees (governance; finance; strategic planning etc); leadership; day-to-day service and staff management; team-building and maintenance of team cohesion; developing specialist services eg eating disorders/under-5 mental health provision. Specialist in Attachment in both adults and children. Advisor in appointment selection and training of foster carers and assessment of potential adoptive parents. Supervisor of residential staff, and consultant to social services on home management structures. Responsible for staff training and development, quality assurance and governance issues. (Band 8C)

psychotherapy clinic. I also act as an Expert Witness in Child and Family Law where my specialist areas are in Attachment, Parenting, substance abuse and Trauma/Neglect. I also act as a Consultant Psychologist and Executive Coach, working with individuals and organisations in the delivery of coaching, mentoring and development programmes. In addition to 25 years' experience in health and social services settings at senior levels, I also have extensive voluntary sector experience in mental health; education, and local government. I have worked with senior leaders as coach and mentor, and have designed and delivered senior team-building and training events in all business sectors and at all levels from basement to boardroom.

In my private psychological therapies practice, I provide clients with a range of therapeutic interventions, including CBT; EMDR; Psychodynamic; personcentred, narrative and bereavement and relationship-based issues. I am also experienced in working with adolescents and young people, alone or with their carers/parents.
