Medico-Legal Practice:

I prepare on average, 60 medical reports per year. The majority have been personal injury, but an increasing number (about one third) are clinical negligence cases. I regularly undertake case discussions both via conference calls and occasionally in Chambers. I have been an expert witness in court.

I attend at least one medico-legal seminar per year and am familiar with CPR Part 35 (30th January, 2017) and Practice Direction 35 Experts and Assessors 35 (updated 1st October, 2023).

I have significant experience in the management of facial trauma and post-traumatic reconstructive procedures, including revision and orthognathic surgery. Many of my reports deal with the sequelae of dento-facial injuries and contemporary reconstruction and rehabilitation using dental implants.

Of the negligence cases that I have been asked to review about 40% involve oral surgery care and include the use of osseointegrated dental implants.

I have specialist expertise in paediatric and adult craniofacial surgery. I am the former clinical lead of one of the four designated craniofacial centres in the UK.

I act as an advisor to the medical defence organisations. This can involve negligence claims, and alleged misconduct involving the governing bodies (GMC and GDC). I also act on behalf of the defence in NHS Litigation cases.

Clinical Practice:

1996 – 2022. My consultant NHS practice was based on an adult and paediatric craniofacial and oral and maxillofacial practice. It included both congenital and acquired deformity. I worked in a Level I Trauma Centre and was on the maxillofacial on-call rota (1 full week in 12) and for the craniofacial unit 1 full week in 4.

1986 – to date. My private practice includes dental and oral surgery, with an emphasis on oral rehabilitation using osseointegrated dental implants. I also have significant experience in the management of complex trauma and facial deformity under private contract (insured and overseas patients).
