## **Clinical Experience**

Since being appointed in May 2020 I have fully established myself as a substantive consultant physician and geriatrician at UHBW. Much of my early work involved caring for patients with covid-19, which posed a unique set of professional, personal and leadership challenges. I have also been integral to the reforming and running of the Older Persons' Assessment Unit. My proudest achievement is founding, leading and developing the Patient focUsed Liaison Service for the Elderly (PULSE), providing liaison services to patients with cardiac disease.

### Geriatrics

My core inpatient work is as a consultant on the Older Persons' Assessment Unit at UHBW, where I lead a multi-disciplinary team providing comprehensive geriatric assessment to patients with frailty. The aims of the unit are to optimise treatment at the point of admission and provide early supported discharge. My role includes leading board rounds, working closely with multiple allied health professionals, and providing holistic clinical care. Specialist areas include managing acute hospital admissions, cognitive impairment, falls including syncope, polypharmacy, discharge planning, and providing end of life care.

I have broad training experiences in medicine for the elderly, including posts in movement disorders, orthogeriatrics and stroke, and community experience at community hospitals.

### General Internal Medicine

I enjoy working as a consultant on the medical take, which provides excellent variety and helps me to retain my skills in general medicine and other specialities. I frequently manage patients with presentations including sepsis, pneumonia, heart failure and other cardiopulmonary diseases. I have experience in high care settings, including coronary care unit, respiratory high care and a medical high dependency unit.

### Cardiology Liaison for the Elderly

Since founding the Patient focUsed Liaison Service for the Elderly in cardiology (PULSE) in 2020, I have provided regular holistic care for elderly and frail patients in the Bristol Heart Institute. My work includes assisting the cardiology team in decision making, managing patients undergoing procedures, advanced care planning and discharge planning. The main clinical benefit of this service is likely to be a significant reduction in bed days by reducing readmissions, as shown in a pilot study.

I enjoy working closely with the Structural Heart Valve Disease Team, where much of my role includes assessing patients' suitability to undergo transcatheter aortic valve implantation (TAVI). I participate in weekly multi-disciplinary team meetings with cardiologists, specialist nurses and cardiac surgeons. I run a weekly outpatient clinic, assessing patients' frailty and comorbidities, with a view to making a plan for TAVI or otherwise. I also review a range of patients with other cardiac conditions, including syncope, heart failure, ischaemic heart disease and devices.

## Audit and Quality Improvement

- 2016 Identification of problematic polypharmacy and early medicines optimisation  
Team member, presented nationally  
In this quality improvement project we trialled methods of reducing polypharmacy, including pharmacist identification and comparing with STOPP/START criteria.
- 2017/18 Anticholinergic burden on an acute frailty unit  
Project lead, presented nationally and internationally  
Data were collected to quantify anticholinergic burden on admission and discharge, showing an overall reduction with routine care. We then trialled targeted interventions that led to a further decrease in anticholinergic burden.
- 2019 Communication of advanced care planning to community services

This quality improvement project found that advanced care planning is often not communicated on discharge. Amendments are being considered to the discharge summary.
- 2020 Management and follow-up of pulmonary embolism

This audit found that despite major improvements in managing pulmonary emboli, trust guidelines are not always adhered to. Ongoing developments include introducing checklists and better defining referral pathways.
- 2023 PULSE activity data: inpatient TAVI in frail patients is associated with high one-year mortality

This quality improvement project compared data for frail inpatients with severe aortic stenosis who were managed with TAVI or conservatively. It found high rates of mortality in both groups

## **Management and Service Development**

### Patient-focused Liaison Service for the Elderly (PULSE)

As described above, I have founded, led and developed this service. This initially involved a large amount of information gathering, including collecting patient demographics, business analysis and stakeholder analysis, alongside running the service clinically.

A pilot study showed the potential to save approximately 700 bed days through reducing readmissions, and this formed the basis for my business case, which was agreed in 2020.

I continue to analyse and develop the service in conjunction with the Specialised Services Division, and I am currently exploring the potential to expand into cardiac surgery.

### Frailty Service Development

Whilst working at Weston General Hospital, a consultant colleague and I helped to develop the case for an acute frailty service. My roles included collecting data, defining assessment pathways, educating allied health professionals and meeting with senior managers to present the benefits of service development.

Our work formed a platform for another colleague to develop the Geriatric Emergency Medicine Service (GEMS), which was the 2019 south west regional winner for 'Urgent and Emergency Care' in the NHS Parliamentary Awards.

## **Medicolegal Experience**

### Medical Negligence

I regularly work as an independent expert witness in medical negligence, providing reports on breach of duty, causation, condition and prognosis. I have experience reporting on behalf of both claimants and defendants, including NHS Trusts. My portfolio includes cases where breach of duty and causation have been advised, and also those where a good standard of care has been demonstrated.

I am affiliated with the multi-award winning McCollum Consultants, who provide active case management and regular in-house training.

I also work for The Medical-Legal Experts Practice (TMLEP), providing advisory reports for NHS trusts to assist in their investigation, response and resolution of claims.

As a geriatrician my experience and understanding of frailty and comorbidity allows me to balance real life outcomes against those expected with standard medical care. I am particularly well-placed to address cases involving the hospitalisation and acute care of frail elderly patients. I am also competent reporting on cases in general internal medicine including sepsis.

### Personal Injury

I regularly report on cases of personal injury, providing assessment of injuries sustained and the impact on condition and prognosis. I use a model of comprehensive geriatric assessment to describe the holistic effects, including medical, psychiatric, functional, social and environmental outcomes, in addition to financial loss. I also provide evidence-based assessments of ongoing prognosis, including any loss of life expectancy.

### Criminal and Coroners' Court

I also have experience as an expert witness advising the police in criminal cases, and in attending inquests to assist the coroners' court.

### Remote Consultation

I am proficient and experienced in conducting remote consultations as a viable alternative to in-person examinations.

### Bond-Solon Training

I have attended Bond-Solon training on 'excellence in report writing' in September 2025.

### Bristol Medical-Legal Society

I regularly attend BMLS dinners and talks, which are an excellent chance to further understand the role of the expert witness and connect with colleagues in this area. I have recently been elected as a committee member of the society.

### Medical-Legal Conferences

I presented at, and helped organise two medico-legal conferences at Bristol Civil and Family Justice Centre. These were attended by a range of medical, legal and other professionals.

I also arranged and led a multi-professional safeguarding conference in Weston-Super-Mare, 2023.

I presented at, and helped organise a webinar with 3PB Barristers, addressing the role of the geriatrician in the Court of Protection in 2024. I also helped to organise a debate in assisted dying with 3PB Barristers in April 2025, where I was a panel member.

I have recently attended expert witness training held by Bevan Brittan (December 2025), The Legal Training Consultancy (September 2025) and an update on Good Medical Practice by the General Medical Council (November 2025).

### UHBW Violence and Aggression Panel

I am clinical advisor to the violence and aggression panel at UHBW, and have recently helped to develop the standard operating procedure for withholding clinical care when patients display aggression towards staff. This has been an excellent experience, balancing the ethical and legal duty to provide clinical care against the right for staff to work in a safe environment.

### College Tutor for Internal Medical Training, Bristol Royal Infirmary

I am jointly responsible for the training and development needs of approximately 40 internal medical trainee doctors and clinical fellow doctors. My role includes annual review of competency progression, rota management, supervision and pastoral support, arranging teaching and liaising with the deanery team.

### 4th Year Tutor in Complex Medicine for the Older Person, University of Bristol

I was responsible for seven students during their clerkships, including providing assessment, making recommendations for progression and providing pastoral care. My role also included conducting case reviews, examination and assisting in tutorials.

### Postgraduate Certificate Medical Education

I completed the Postgraduate Certificate of Medical Education with a distinction in four modules, including one submission that is now used as an exemplar essay. This has taught me to become a knowledgeable, adaptable and inspiring teacher, and I enjoy using a variety of evidence-based teaching methods to suit each situation.
